# What are Peer Support Values?

- Centers **mutuality** and genuine relationships of support
- Recognizes the validity of **multiple pathways** to self-defined “recovery”
- Aims to understand the role trauma can play in people’s lives and offer **trauma-informed** peer support
- Advocates a **person-centered** (or self-directed) approach to healing rather than one-size-fits-all solutions
- Connects with others from a place of **curiosity**
- Respects and views the people they support (**peers**) **as the experts** in their own lives and experiences
- Offers support based in the recognition of personal strengths/assets (**strengths-based**) rather than defects, deficits, or diagnoses centered in pathology
- Places the principle of **self-determination** in a foremost position when navigating ethical questions



# How Does this Impact Systems?

- Peer culture focuses on mutuality, transparency, respect, and self-determination. These stand in contrast to the values current systems have been built upon
- Peer specialists often have the burden of holding up the mirror to systems, and those working within them, for reflection
- The foundational peer value of “multiple pathways” can seismically shift systems in new directions



# Peer Specialists' Roles

- Cultivate empowering and supportive relationships
- Use self-disclosure and their own lived experience as a valuable tool
- Provide information about community and recovery-oriented resources upon request
- Assist in supporting peers, even in crisis\*
- Value self-determination as a guiding ethical principle\*
- Facilitate person-centered goal setting
- Communicate effectively with peers, other team members, and clinicians\*
- Create an environment of respect for peers and those with lived experience
- Seek to understand the roles culture, community, and identity play in peers' lives
- Practice trauma-informed approaches in peer relationships and work places
- Inspire hope for recovery and wellness
- Affect positive change in systems (Systems Disruptors)\*

# California's Billing Structures for Peer Support Services


- California currently allows billing for peer services in two programs:
  - The Specialty Mental Health Services
  - Drug Medi-Cal Organized Delivery System
- However, they must do so under the provider type “other qualified provider”
- The Department of Health Care Services is currently in the process of establishing peers as a unique provider type within specific, reimbursable services
- This provider type is expected to launch on January 1, 2022
- Billable peer services are expected to begin on July 1, 2022



## Barriers to Peer Work in Clinical Settings

- Systemic and individual views and paternalization of people with lived experience
- Misunderstandings and willful erasure of the history and foundations of peer work and certification
- Different service models having different approaches to supporting people experiencing “crises”





# Breaking Down Systemic Barriers

- Individual and collective reflection and education
- Acknowledgement of harm done by systems to others working within them: clinicians, social workers, counselors, case managers, etc.
- Re-centering the voices of the people receiving services to the core of the systems in which we work



# What can Successful Integration Look Like?

- Development of collaborative treatment teams
- Wellness focused workplaces
- Integration of new value systems into existing service systems
- The development of completely new service systems
